ORDER

Based on the report of Indian Meteorological Department regarding the deficit in rainfall during the North-East Monsoon 2017 and the drought assessment report received from the State Drought Monitoring Cell, vide the

powers vested with the Kerala State Disaster Management Authority (KSDMA), as per Section 22(2)(b) of the Disaster Management Act, 2005, the KSDMA has directed the State Relief Commissioner to declare the following districts as 'drought' affected during the Rabi season of 2017-18 and also directed to grant sanction to the District Collectors concerned to utilize fund from State Disaster Response Fund (SDRF) for the drought response activities, as per the powers conferred in Section 18(2)(f) of the Disaster Management Act, 2005.

2. Based on the directions of KSDMA, the following districts of the State of Kerala are declared as drought affected during the Rabi season of 2017-18:
