**S. R. O. No. 263/2016.**—In exercise of the powers conferred by sub-section (1) of section 78 read with sub-section (2) of section 14 of the Disaster Management Act, 2005 (Central Act 53 of 2005), the Government of Kerala hereby make the following rules further to amend the Kerala State Disaster Management Rules, 2007 issued by notification under G. O. (P) No. 71/2007/DMD dated 1st March, 2007 and published as S.R.O. No. 201/2007 in the Kerala Gazette Extraordinary No. 426 dated 6th March, 2007, namely:—

## RULES

1. *Short title and commencement.*—(1) These Rules may be called the Kerala State Disaster Management (Amendment) Rules, 2015.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala State Disaster Management Rules, 2007, in rule 3,—

(i) after sub-rule (3), the following sub-rule shall be inserted, namely:—

“(4) The Head (Scientist) of the State Emergency Operations Center shall be the Member Secretary (ex-officio) to the State Authority.”

(ii) sub-rule (4) shall be renumbered as sub-rule (5).

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have decided to designate The Head (Scientist) of the State Emergency Operations Center to be the Member Secretary (ex-officio) to the State Authority. Hence the Government have decided to amend the Kerala State Disaster Management Rules, 2007, suitably.

This notification is intended to achieve the above object.
